**COMMISSION ORDER NUMBER 2015-002**

AN ORDER OF THE COMMONWEALTH CASINO COMMISSION SUSPENDING SECTION 175-10.1-1225 (SCHEDULE OF FEES) OF THE COMMONWEALTH CASINO REGULATIONS AS THEY PERTAIN TO THE CASINO LICENSEE TO TEMPORARILY ALLOW DEFERMENT OF THE DUE DATES FOR THE CASINO REGULATORY FEE UNTIL FURTHER ORDERED BY THE CHAIRMAN; AND FOR OTHER PURPOSES.

**WHEREAS**, on or about September 25, 2015, the Commonwealth Casino Commission passed Commission Resolution 2015-002; and,

**WHEREAS**, Commission Resolution 2015-002 empowers the Chairman to issue an Order suspending Section 175-10.1-1225 (Schedule of Fees) and any other portion of the Commonwealth Casino Regulations as they pertain to the Casino Licensee to temporarily allow deferment of the due dates for the Casino Regulatory Fee until further Ordered by the Chairman; and,

**WHEREAS**, the Chairman is in agreement with the spirit and language of Commission Resolution 2015-002 and is not aware of any reason why the Resolution should not be acted upon; and,

**NOW THEREFORE, IT IS HEREBY ORDERED** that Section 175-10.1-1225 (Schedule of Fees) and any other portion of the Commonwealth Casino Regulations as they pertain to the payment of the Casino Regulatory Fee by the Casino Licensee are hereby immediately temporarily suspended until further Ordered by the Chairman; and

**IT IS FURTHER ORDERED THAT** the Chairman of the Commonwealth Casino Commission should be, and hereby is, empowered to issue an Order suspending Section 175-10.1-1225 (Schedule of Fees) and any other portion of the Commonwealth Casino Regulations as they pertain to the Casino Licensee to temporarily allow deferment of the due dates for the Casino Regulatory Fee until further Ordered by the Chairman; and,

**IT FURTHER ORDERED THAT** the requirements of § 175-10.1-025(d) and (e) as they pertain to casino service providers and other miscellaneous fees are not suspended; and,

**IT FURTHER ORDERED THAT** this suspension shall remain in effect until the Chairman of the Commonwealth Casino Commission is satisfied that the public has had an opportunity to comment on the Regulations as they were or may be published in the Commonwealth Register and is further satisfied that the Commission has been granted sufficient authority from the legislature to properly regulate the industry; and,

**IT IS FURTHER ORDERED THAT**, the Executive Director should be, and hereby is, empowered to take any and all actions necessary to ensure that the intent of this Resolution and the Orders authorized above are carried out.
